

# Science Odyssey Contest:

## OFFICIAL RULES AND REGULATIONS

### 1. ELIGIBILITY

NO PURCHASE NECESSARY.

This Contest is open to legal residents of Canada, excluding residents of Quebec, who are between the ages of 2 and 6 years old as of May 26, 2020, Employees of Bayard Canada and the Natural Sciences and Engineering Research Council (NSERC) (together "Contest Sponsors"), Magformers, and their respective parents, affiliates, subsidiaries, advertising and promotional agencies and the immediate family members and persons they reside with are not eligible to participate.
